**MANDATORY MEMBERSHIP REGISTRATION & PAYMENT POLICY**

NO EXCEPTIONS.**

**Membership registration is completed through payment submission, the applicant is legally deemed to have accepted all terms below.**

---

**1. REGISTRATION REQUIREMENT**

Membership is **ONLY valid** once:

- Full payment is received; and
- All required information is properly submitted

Any incomplete, incorrect, or missing information will result in **automatic rejection, delay, or cancellation** of membership **without notice**.

---

**2. REQUIRED INFORMATION (MANDATORY)**

The following **MUST** be included in the e-transfer message:

- **Full legal name**
- **Non-Mississauga residents MUST declare their city of residence.**

Failure to provide complete and accurate information will result in **membership being denied or voided**.

---

**3. RESIDENCY DECLARATION**

Non-Mississauga residents **MUST** declare their city of residence.  
Failure to disclose may result in **revocation of membership**.

---

#### 4. CONSENT (AUTOMATIC)

By submitting payment and the required registration information, each applicant acknowledges and consents to the collection, use, and disclosure of their personal information by the Club and to the City of Mississauga for administrative, verification, reporting, and compliance purposes, including participation in the Community Group Registry Program (CGRP), as may be required from time to time.

If you do not agree, **DO NOT submit payment.**  
Payment = **full legal consent.**

#### 5. MEMBERSHIP CONDITIONS

- Memberships are **STRICTLY NON-TRANSFERABLE**
- Memberships are **NON-REFUNDABLE UNDER ALL CIRCUMSTANCES**

Membership remains **INVALID** until fully approved by the Club.

---

#### ZERO-TOLERANCE NON-MEMBER COURT ACCESS POLICY

This policy is **STRICTLY ENFORCED.**

- Non-Member Access Fee – Mandatory — **MANDATORY**
  - Payment must be completed via e-transfer **BEFORE ENTERING THE COURT**
  - **NO PAYMENT = NO ENTRY**
  - Members bringing guests are **FULLY RESPONSIBLE** for ensuring payment is completed in advance
  - Any unpaid individual is **STRICTLY PROHIBITED** from accessing or using the courts
